Course Objective: The main objective of this discipline is to familiarize students with the main stages of the history of Kyrgyzstan from ancient times to the present day. It should give them a general theoretical understanding of the methodology for studying history, including the basics of historicism, the influence of the natural environment, social and economic factors, the civilizational approach and other methods. From the point of view of other people living in this territory, and the Kyrgyz people themselves, students will learn about the main historical dates, events and personalities that had a great influence on the development of the Kyrgyz Republic.

After study of the discipline the student must know:

Knowledge: -main dates, events and personalities in the history of Kyrgyzstan;

-basic principles of historical research and related sciences;

-concepts of socio-political development of the nomadic peoples of Eurasia;

-features of the material and spiritual culture of Kyrgyzstan from ancient times to the present day;

-development of modern society and culture in Kyrgyzstan.

Skill: -to develop your own qualities of an intellectual personality, the ability to think analytically and expand your erudition;

-to be able to independently work with historical literature, possess the skills of comparative analysis of various historical events and facts.

Attitude: ability to see the processes and events in the whole diversity of their interrelations and interdependencies.

Methodological instructions for the implementation of independent work on the discipline

When studying the discipline by sections, the student is obliged to prepare a written work in the form of an abstract.

Abstracts are one of the main forms of independent work of a student and a means of monitoring the assimilation of educational material in the amount established by the program.

An abstract is a summary of the content of a monograph (one or more books), a thematic group of scientific articles, materials of scientific publications on a specific problem or issue.

The volume of the abstract should be at least 20 pages (A4). As a rule, the abstract consists of three parts with a title page: introduction, main part and conclusion.

The abstract is issued in the following electronic format: set - Word, font: Times New Roman, 14 size, 1.5 line spacing (for footnotes and page numbering 10 size). Pages are numbered at the top, in the right corner.

The abstract is submitted 12 days before the completion of the study of the materials of one of the units/modules. Therefore, after the units/modules, the independent work for this unit is not accepted (-20).
